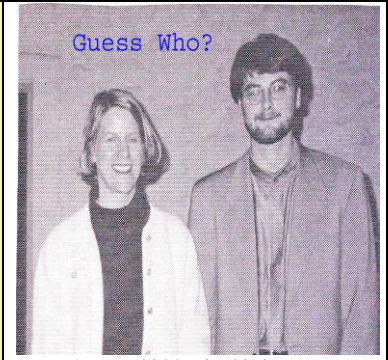

## Dr. Diana Skroch Nominated NDMTA Foundation Fellow

The North Dakota Music Teachers Association is proud to announce the nomination of Dr. Diana Skroch as North Dakota's newest Foundation Fellow candidate. The MTNA Foundation Fund Fellow Program honors deserving individuals who have made significant contributions to the music world and the music teaching profession.

Diana has been a very active member of the NDMTA, serving on the state board in numerous capacities including state president. She has chaired a state conference and served as Rally Adjudicator, ND Junior Festivals Chair, Southeast Central Festivals Co-Chair, adjudicated for the National Guild of Piano Teachers, Valley City State University Student Chapter Advisor for the Music Educators National Conference, and MTNA and NDMTA Competitions Site Chair.

For twenty-five years Diana served her community as a private piano teacher, was an active member of the National Federation of Music Clubs, entering her students annually in the Junior Festivals, and was Junior Festivals Chair for four years. In addition, she encouraged the arts through her membership in the Valley City Area Concert Association, holding the office of president for three years.

Diana just completed a second two-year term as Chair of Competitions for MTNAs West Central Division which includes an eight-state area. Prior to that she held a three-year term as Coordinator of Junior Competitions in the WCD.

Diana's music education includes a Ph.D. in Music Education/Piano Pedagogy from the University of Oklahoma, an M.A. in Music from the University of North Dakota, and three B.A. degrees from Valley City State University (Music, Art, and Spanish). Currently, she is Professor of Music and Chair of the Division of Fine Arts and Department of Music at Valley City State University. She also lectures frequently throughout the region from a list of over a dozen pedagogical topics, sharing her vast knowledge and experience with fellow musicians.

NDMTA is very pleased to nominate Dr. Diana Skroch as a Foundation Fellow and encourages all members of NDMTA to make contributions to the MTNA Foundation in her name. When \$1,000 has been collected, Diana will become North Dakota's eighth Foundation Fellow and will be honored at the MTNA Conference Gala in 2009. ## Discovery Corner

Our country is rich in musical heritage, with many folk songs available for teaching. However, I am always surprised to see how many young children, as well as college students don't know familiar folk songs. Thus, a great opportunity exists to teach folk songs to our students to familiarize them with music from our nation's history. In the piano studio, folk songs can be taught by ear, enabling the student to discover the melody first by singing, shaping, and finally by playing.

My experience with teaching folk songs by ear began when I was a doctoral student at the University of Kansas. I taught at a piano studio which was owned and directed by Dr. Christopher Hepp, who taught piano and pedagogy at the university. Under his guidance, I learned of the importance of teaching songs by ear as a way to supplement method books. Through the teaching of folk songs students can learn melodic direction, tone production, rhythm, and harmony without ever seeing the symbols representing these elements, thus eliminating the barrier sometimes caused by reading music.

When first teaching melodies by ear, begin with songs with a 3-note range such as Hot Cross Buns, Mary Had a Little Lamb, I'm Tramping, It's Me Oh Lord, or Good Pierrot. I often teach Hot Cross Buns when interviewing new students and I am always amazed that most young students do not know this song! I begin by singing the melody, then asking the student to join me. After this, we sing it together and shape the direction of the notes (high, middle, and low) to corresponding spaces in the air with our hands. Finally, we sing and play the folk-song melody at the piano beginning on the three black-key group. The student can learn songs with their hands independently, then play with their hands together to work on coordination. The student can also transpose each song to several other key positions (C-D-E; F-G-A; G-A-B).

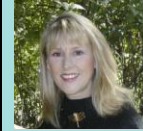
Once students have mastered 3-note songs, the range can be expanded to songs with five notes. These songs work well in conjunction with or prior to the student's knowledge of pentachords because they can be transposed. The act of transposition breaks up the monotony of the C Major position and gives students the opportunity to discover and explore other key areas. Some examples of 5-note songs that can be used include The Fish Song, Ode to Joy, Lightly Row, When the Saints Go Marching In, and Erie Canal (minor pentachord). The ability to read flats, sharps, or rhythms on the staff is not necessary in this exercise and is not a deterrent in choosing keys. I begin by telling young students the relationship between white and black keys. For example, I tell them that D position is W-W-B-W-W. The next step is to teach the name for the black key in D position and show the corresponding symbol. This exercise is important because once students reach the point in their method books where they play in, for example, D position, they will already have had the experience of playing in that position. I find that students get excited because they have prior experience playing in different positions and are better able to read patterns in music!

Besides rhythm and transposition, other musical elements can be taught in conjunction with teaching songs by ear. When teaching by ear, students become more aware of their hand position because they can watch their hands while playing and are not distracted by note reading. Also, students are able to play with varying degrees of dynamics and articulation, increasing their musicianship skills. Once students are comfortable playing the melody, they may begin accompanying their melody with the opposite hand using only the tonic triad first, then expanding to the dominant, subdominant, and even secondary chords. Different combinations of melody and harmony can also add variety to each song. Students may play the melody in their right hand, left hand, or both; the melody could be played with the right hand while harmonizing with the left hand or vice versa; or the students may only play the accompaniment pattern with the left hand playing the chord root while the right hand plays the chords. The students may choose to sing along while they play, or the teacher may play the melody and/or accompaniment as a duet.

By teaching folk songs by ear, students can focus on more complex melodies and rhythms that they might not yet be able to read. By hearing the rhythms and figuring out melodies, students gain important aural skills that will help them to identify similar patterns when reading musical

## Bits and Bytes

### Tech Tips

Looking for a quick way to introduce composition into your studio with technology?

I'll be presenting "Integrating Loop-Based Software into Student Compositions" at the national conference in March. What is loop-based software? Why should I consider using it?

Loop-based software utilizes audio or midi files of pre-made bits of music, known as loops, which are ready-made to string together into such things as ostinatos, bass lines, chord progressions, or melodies. The beauty of these ready-to-use files is that they serve as support structures for students as they begin to understand how music can be organized. For example, using Macintosh's *Garage Band* program, which is part of the iLife suite and comes loaded on all new Macs, students can choose from a myriad of drum beats or styles, like Latin or Reggae. Click and drag these files into position in the sequencer. They can be copied and pasted as many times as needed, and they can be mixed up (shortened, edited, or expanded from other files) into any new pattern that the student might desire. I use



notation in repertoire. Not only do students learn folk melodies (or are being exposed to the folk music tradition), they are also learning hand position, rhythm, musicianship, harmonization and transposition. Giving students an "ear song" in addition to their method book pieces or other repertoire adds another dimension to their lessons and is often a highlight for students.

**URGENT MTNA NEWS From Nancy and Lane Stokes:** Since Nancy won the right to continue teaching in our home in Dekalb County, Georgia in 2002, she and I have served as "national advocates by default" for MTNA. The latest teacher to call upon us for help was Julia Distelhurst. I spent 16 hours a day, seven days a week, for one month, trying to raise enough email and telephone support to save her livelihood. The 488 emails and some phone calls gave Julia a "stay of execution" for 30 days. Of the 488 emails, only 350 came from MTNA members. It is apparent to us that you are not aware of the gravity of the situation facing music educators in today's society. **Here are some facts:** Most in-home music teachers are already in violation of a neighborhood, city or county law. The webpage [www.USA.gov](http://www.USA.gov) lists 5,680,000 known ordinances in use that prevent music instruction by

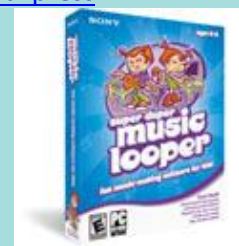
either limiting the numbers of customer contact or by disallowing all customer contact. This number represents only a fraction of the ordinances in use. The ordinances are passed with no intent of enforcement until there is a complaint. It doesn't matter if the complaint is legitimate or not. The law requires an Enforcement Officer to cite the offender and the burden of proof lies with the offender. The choices for one accused by citation are grim. 1) Stop teaching in the home and get a job elsewhere to provide a needed income. 2) Teach in a music store or commercial building. 3) Give up a lifetime of developing your God-given gift and service to others. 4) In rare cases, convince the politicians to allow you to continue until the next complaint—if your nerves will allow it.

this technique for practicing blues or other styles of music as well, setting appropriate tempos and letting the students play along with their own rhythm section! Using this drum pattern as a starting place, students can improvise a melody that fits with the new rhythm. They can record that component and then go to work on a harmony that might fit (or they could use one of the premade harmony riffs).

Sentence starters are effective ways to help students start writing; loops are an effective means to start students off with a solid foundation of sound from which to build. They are enthusiastic about these programs and love experimenting with the loops to find just the perfect one. For PC users, start out with *Super Duper Music Looper* by Sony, for ages 6-9. 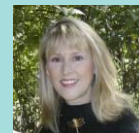

- IMTF Chair: Sheryl Kjelland, reported that she wrote an article for the newsletter and sent a tape to the Greater Grand Forks MTA for viewing. She is currently thinking ahead to the IMTF luncheon and welcomes suggests on topics or presenters.

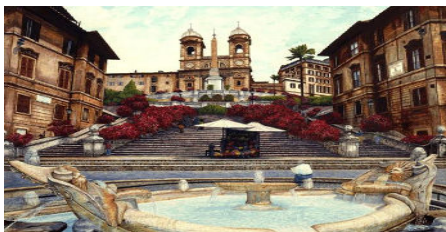
