NDMTA is pleased to announce the nomination of Ruth Stenson for NDMTA's 2010 Foundation Fellow. The MTNA Foundation Fund Fellow Program honors deserving individuals who have made significant contributions to the music world and the music teaching profession.

Ruth was born on April 10, 1955 and passed away on March 30, 2009, after a lengthy battle with cancer. She graduated in 1977 with a bachelors' degree in music education from Pacific Lutheran University in Tacoma, WA and taught in Sykeston, ND; Carrington, ND; Gillette, WY; and Bottineau, ND. She then raised 3 children with her husband Bob in Grafton, ND, and served as organist at Grafton Lutheran church and taught private piano lessons. Living in Fargo for one year, she gave piano lessons and was choir director at Pontoppidan Lutheran church. In the fall of 1997, the family moved to Thief River Falls, MN, where she began teaching piano lessons, played organ at Trinity, and was the music director, choir director, and accompanist at Redeemer Lutheran Church. In 1999, Ruth became the choir director at Franklin Middle School in Thief River Falls. Besides her activities at Redeemer Lutheran Church, she also was active in Scouts and Community Concert Series Board. She held membership in the American Guild of Organists and the North Dakota Music Teachers Association, where she served in various offices.

NDMTA encourages all members of NDMTA to make contributions to the MTNA Foundation in her name. When \$1,000 has been collected, Ruth will become North Dakota's 10th Foundation Fellow and will be honored at the MTNA Conference Gala in 2010. Rally Newsletter Article

As you are preparing for a new year of teaching, you are probably thinking about theory options for your students. I would like to suggest something that I used last year and felt was very worthwhile. The Illinois Music Teachers Association publishes workbooks to complement their Rally materials. Our Rallies in North Dakota are built on the Illinois Rally Materials, so these workbooks work very well in Rally preparation, both for students and teachers.

These workbooks are available to coordinate with the various levels of Rally, beginning with Level 2. They provide excellent preparation for students who will be taking Rally tests and provide an excellent learning experience even for students who are not involved with Rally. They contain exercises in notation, rhythm, terms, music signs, aural skills, harmonization, score analysis, sight reading, transposition, composers, and also contain technique skills that are written out for your student, such as 5 finger patterns, scales, chord progressions, tonic triads, arpeggios. There are play back, interval identification, and dictation examples included for use by teachers and students. I have used these workbooks with my students for a year and I have been very pleased with them. The cost is approximately \$8.00 per workbook.

The Healthy Musician Submitted by Lisa Schuler, CTM

Melody Bober's first session at the NDMTA state conference really tuned our members into the health needs of our profession. The information for the session was largely based on the book "A Symposium for Pianists and Teachers: Strategies to Develop the Mind and Body for Optimal Performance" from Heritage Music Press. The following four areas were discussed.

- 1. <u>Healthy Lesson Environment</u>: Teachers need to be caring, build self esteem, nurture student's independence and give them honest feedback.
- 2. <u>Benefits of Fitness</u>: Members quickly became aware of how much more alert one can feel by doing simple movements. Bober discussed aerobics, strength training, nutrition, hydration, and stretching. The group then actually messaged their hands, warmed up their fingers and moved to music while singing, "Hot, Hot, Hot". ☺
- 3. <u>Healthy Attitude Toward Performance</u>: Performers can lower their heart rates by breathing, releasing tension, and visualizing the performance. Melody Bober suggested recording and listening to the piece to be performed.
- 4. <u>Benefits of Humor</u>: Laughter helps the heart by increasing circulation, endorphins are released, and it helps reduce headaches and tension. Melody suggested telling jokes, to watch comedies, clip cartoons from the paper, laugh with others, and make fun of your fears.

Following each of the 4 topics, members were put into pods to discuss and share their experiences. It was a great way to get members communicating and learning from each other. The session concluded with the following list of "Tips for a Successful Performance".

- 1. Select appropriate repertoire
- 2. Encourage through preparation
- 3. Review elements of on stage etiquette
- 4. Develop self confidence
- 5. Provide a variety of performance opportunities
- 6. Work on concentration and relaxation skills
- 7. Try out concert clothing
- 8. Focus on conveying the meaning of the music
- 9. Take good care of yourself
- 10. Emphasize the joy of performing

Oxford publishes The Musician's Way, by Gerald Klickstein

In August, Oxford University Press released The Musician's Way: A Guide to Practice, Performance, and Wellness by longtime MTNA member Gerald Klickstein (360 pp. \$24.95). The Musician's Way presents comprehensive, research-driven guidance geared to all aspiring performers (especially college and pre-college music students) as well as their teachers. It also employs an extensive companion website, which includes free resources, and downloadable practice aids: www.MusiciansWay.com.

The book is organized in three parts:

- Part I, *Artful Practice*, helps musicians interpret and memorize compositions, fuel motivation, collaborate, and more.
- Part II, *Fearless Performance*, lifts the lid on the causes of nervousness and guides musicians to become confident performers.
- Part III, *Lifelong Creativity*, surveys tactics that equip performers to prevent music-related injuries and thrive as creative artists.

Gerald Klickstein is Professor of Music at the <u>University of North Carolina School of the Arts</u> and an active classical guitarist. In addition to performing and teaching, he serves on College Board's National Task Force for the Arts in Education and on the board of the American String Teachers Association.

To Fine Arts Building from the Parking Lot: The Fine Arts Building is on the Southwest corner of the Hitt and University intersection; the music entrance is on the south end of the building.
