NDMTA Executive Board Meeting, Jan 25, 2020

President Vangie Johnson Parker called the meeting to order. Roll call: Vangie Johnson-Parker, Sharon Gegelmann, Dianna Anderson, Michelle Kallod, Gloria Bethke, Kathleen Johnson, Sue Nagel, Karen Okerland, Corinne Nustad, Lisa Schuler, Jean Guenther, Priscilla Keogh, Cheryl Dockter.

Officers Reports

Secretary: Minutes from the October 19, 2019 board meeting were posted online. Two corrections to the minutes were made. There should be 7 new members not 17. And NDCS should be changed to NDCA. Minutes were approved as corrected.

Treasurer: Michelle Kallod reported assets of \$41,096.95, income of \$2,835.44 and expenses of \$8,089.13.

Vice-President/Commission Composer: Dianna Anderson reported that she has registered for the national conference.

She has also gained permission from MSU to form a collegiate chapter. The first meeting was Jan. 16. A motion to accept the new collegiate chapter at MSU was made by Lisa Schuler, 2nd by Priscilla Keogh. Motion carried.

Several composers were reccommened for the 2021 commissioned composer. Sean Neukom was selected by a unanimous vote.

President: Vangie Johnson Parker reported that she will be attending a meeting on Feb 28 with Dianna Anderson and Lisa Schuler to plan the 2021 conference in Minot. They will also discuss suggestions for the new Collegiate Chapter at MSU.

All the contracts for the 2020 conference in Fargo have been sent out, but not all are yet signed.

Since we are now not eligible for the NDCA grant, we are currently looking for other grant suggestions.

Committees

Conference: Corinne Nustad presented the conference registration sheet. Full conference will be \$100, 1 day \$50, and non-members \$120. Late registration fee will be \$15. This year a parking pass will be required which will be \$2/ day, or \$6 for the full conference. Lunch will be \$15, Banquet \$26. Kathleen Johnson moved, Gloria Bethke 2nd to accept the registration sheet. Motion carried.

The conference schedule was presented. It was suggested to add the following at noon on the last day – closing remarks, door prizes and silent auction results. Priscilla Keogh moved and Dianna Anderson 2nd that the conference schedule be approved with changes. Motion carried.

Since their collegiate chapter is in early formation stages & Minot is without a current local association, statewide participate is important to help make this new conference venue work. More information and signups will be available at the June board meeting.

Local Association reports were given.

Meeting adjourned.



Conference Presenter - Marvin Blickenstaff

Marvin Blickenstaff is known throughout North America for his performing, lecturing, and teaching. Blickenstaff holds degrees from the Oberlin Conservatory of Music and Indiana University where he received both academic and performance honors. He frequently lectures at state and national conventions of music teachers and has been featured on five webinars sponsored by the France Clark Center for Keyboard Pedagogy. In 2007 he was named a Fellow of the Royal Conservatory of Music in Toronto and in 2009 he received the Achievement Award, the highest honor given by the Music Teachers National Association. He has been named Teacher of the Year by both the Indiana and Pennsylvania Music Teachers Associations and was honored in 2013 by the National Conference on Keyboard Pedagogy. Steinway & Sons has honored him with induction into



their *Teacher Hall of Fame.* Residing in the greater Philadelphia area, Blickenstaff teaches in his home studio and at The New School for Music Study in Princeton, NJ.

Conference Recitalists - Excelsior! Trio

Although Excelsior! Trio was officially formed in 2009, Deb, Russ, and Jay, members of the music faculty at Concordia College in Moorhead, MN have been performing together on and off since 2001. Early on they discovered a deep sympatico for each other's musical styles, technique, and artistic personalities, and decided to "take it to the next level" by forming a professional trio, especially encouraged by a number of fellow professionals from around the coun-



try. From Los Angeles and Cleveland, Minneapolis and Athens, GA, to St. Andrews Scotland and Fienza, Italy audiences have enthusiastically responded to the high-energy music making of Excelsior! Trio. Performing an eclectic mix of classical, jazz, folk, and contemporary chamber music, the unique combination of flute, saxophone, and piano results in an unusual variety of sound, timbre, and style, making Excelsior! Trio a satisfying and entertaining ensemble for all occasions.

Conference Presenter - Christian Heaford



Christian Heaford is a full time Registered Piano Technician (RPT) with over 30 years in the field.

He began his training while attending Berklee College of Music in Boston, MA and currently services pianos in the Fargo-Moorhead area. He is a graduate of the Steinway comprehensive piano service course, as well as Yamaha's prestigious "Little Red School House" for advanced piano service techniques.

As the co-owner of Piano Forte with his business partner, Nate Mattison, RPT Christian enjoys his long term relationships with clients such as Concordia College, NDSU, Minnesota State University, FM Symphony Orchestra,

FM Opera Company, FM Choral Artists, Master Chorale, as well as dozens of other music organizations, stages and churches.

Christian enjoys teaching aura piano tuning and is proud that some of his former students have gone on to work for him or pursue careers themselves as piano technicians in other markets. You can often catch him playing piano at Hope Lutheran Church South, North and West campuses.

Commissioned Composer - Nicholaus Meyers

Nicholaus Meyers, a native of Georgia, is currently Director of Bands and Percussion at East Central University in Ada, Oklahoma. Dr. Meyers directs the ECU marching band, wind ensemble, concert band, percussion ensemble, teaches applied percussion, conducting, and other courses in the music education sequence. Additionally, he organizes a large annual high school marching band competition "Tigerpalooza" at East Central University that brings marching bands from across the state of Oklahoma to compete. Before coming to ECU, he was the Assistant Director of Athletic Bands at North Dakota State University in Fargo, North Dakota and Director of Bands, Percussion, and Composition at Valley City State University in Valley City, North Dakota. Additionally, he serves as a faculty member at IMC (International Music Camp) and as a member of the Fargo-Moorhead Symphony.



Before coming to Oklahoma, Dr. Meyers also taught at Augusta State University, Troy University, and Augusta Technical College and was the Assistant Director of Bands at Lakeside High School in Evans, Georgia. Other ensembles he has performed with consist of the Augusta Symphony, Augusta Opera, Augusta Players, Augusta Chorale Society, Greater Grand Forks Symphony, Oak Ridge Symphony, and Fort Gordon Dinner Theater. Dr. Meyers keeps an active schedule giving masterclasses, discussions, adjudicating, serving as a honor band clinician and performing.

He is also a commissioned composer whose works have been performed throughout the United States and Europe. His first CD "Stepping Away" was released on September 19, 2016 which features his solo piano music. Meyers in currently working on his next CD which will contain several of his works for percussion.

He is currently Chair of the Percussive Arts Society (PAS) Composition Committee, past President of the PAS North Dakota Chapter and Chair of the Oklahoma Intercollegiate Band. Further memberships include the American Society of Composers, Authors, and Publishers (ASCAP), Percussive Arts Society (PAS), and the College Band Directors National Association (CBDNA).

Meyers received his degrees from Augusta State University (BM), the University of Tennessee (MM) and North Dakota State University (DMA). Additionally, he studied at the University of Georgia and in Oslo, Norway with Principal Percussionist Christian Berg of the Oslo, Philharmonic. He is sponsored by Aquarian Drumheads, Black Swamp Percussion, Gon Bops, Innovative Percussion, Sabian Cymbals, and the Yamaha Corporation. Many of his works are published by C. Alan Publications, HaMar Music, and Per-Mus Publications.
